Dr. Bridget J. Crawford

Bridget J. Crawford is a professor at the Elisabeth Haub School of Law. Prior to joining the Haubaw faculty in 2003, she was a practicing attorney at Milbank LLP, where she specialized in taxation and estate planning.

Professor Crawford is a graduate of Yale College (BA), the University of Pennsylvania School of Law (JD), and Griffith University (PhD) in Brisbane, Australia. At Pace, she teaches courses in taxation, trusts and estates, corporations and partnerships, and feminist legal theory. She is one of 26 professors profiled in the book *What the Best Law Teachers Do*

Professor Lamartina has an established national and international reputation as a scholar and translator of contemporary theater of Spain. She has published numerous articles in the field, co-authored several critical Spanish theater anthologies that are widely used in academic courses throughout the nation, and contributed a substantial number of book chapters, encyclopedia entries, prologues, and introductions included in academic manuscripts or anthologies on contemporary Spanish theater. Many of her translations have been published and, more importantly, staged at commercial and university venues both in the United States and abroad, including in South Korea and India.

Since her arrival at Pace in 1984, Professor Lamartina has been a teacher and scholar intent on linking classroom learning of foreign language with scholarship, and on cultural and linguistic immersion. She has taught and organized more than 20 faculty-led Pace study abroad courses throughout Europe and Latin America and mentored undergraduate language students to translate and publish theatrical texts.

### Professor Bennett L. Gershman



Professor Bennett L. Gershman has been a professor of law at the Elisabeth Haub School of Law since its founding as the Pace Law School in 1976. Prior to coming to Pace, Professor Gershman was a prosecutor in the New York State Attorney General's Office, where he argued cases in state and federal courts involving public and political officials charged with corruption.

Professor Gershman has written four books, over 75 articles in law journals, and hundreds of book reviews, essays, and op-ed pieces. His treatise, *Prosecutorial Misconduct*, initially published in 1985 and now in its 2nd edition, has become a preeminent resource for scholars and practitioners seeking guidance on wrongful convictions.

As a leading authority in the country on prosecutorial misconduct, Professor Gershman is continuously called upon by the news media for his expertise. He is routinely quoted by the New York Times, the Washington Post, the Los Angeles Times, and The Wall Street Journal, as well as by a host of local publications. He has served as an expert witness on prosecutorial misconduct in numerous criminal cases. He also has devoted much of his time to training prosecutors and judges.

Attesting to his teaching effectiveness, Professor Gershman has received the Outstanding Professor of the Year award from graduating students eight times in the past 20 years. His sensitivity to the student experience is evidenced by his book, *The Law School Experience: Law, Legal Reasoning and Lawyering* (2000; coauthored with Lissa Griffin), which seeks to demystify

Dr. Joseph C. Morreale

Dr. Morreale has been a professor of economics and public administration at Dyson College of Arts and Sciences and an academic administrator at Pace University for 29 years. He received an MA and PhD in Economics from the University at Buffalo, SUNY, and an MS in Higher Education Administration and Finance from the University at Albany, SUNY.

Dr. Morreale has been an active researcher with a wide range of scholarly experience in public finance and administration, health care economics, environmental economics, faculty development and evaluation, and program development in higher education. He has authored six books, numerous book chapters, and peer-reviewed articles, the most significant of which is a three-volume work on enhancing senior faculty vitality and posttenure review, which gained national recognition.

Dr. Morreale has held positions as provost, senior associate provost, vice president, associate vice president, vice provost, division chair, and department chair. He negotiated and brought to Pace University Inside the Actor's Studio, followed by the MFA program in Acting, Directing and Playwriting. He also brought to Pace the first NYC-based Confucius Institute, increasing Pace's international reputation and creating faculty, staff, and student exchanges and joint programs with Chinese universities, and negotiated the establishment of the Wilson Center for Social Entrepreneurship.
